COMMENTS:

Noble Energy respectfully request to change to COA on the Rampart A32-739 (123-50930) regarding PDC's Miller 33-29 (123-19479) from option 1/2 to option 4. Noble would like to propose that this well be changed to Option 4 where the well would be temporarily abandoned with a cast-iron bridge plug with 2 sacks of cement on top and a 5K wellhead installed at surface, and pressure transducers installed on the tubing, casing, and surface casing with continuous monitoring. There is additional cement placed in the annulus (3,012 – 3,868ft) across the Parkman formation that should act as an additional barrier. Additionally, the annual bradenhead tests have shown 0psi in 2020 & 2021, and the monthly pressure checks have shown 0psi YTD.
