Corrective Action:	<p>The well location and access road appear to meet final reclamation regulations and standards, and appear reflective of reference areas. Unable to find evidence of oil and gas activities and/or disturbances.</p> <p>The tank battery does not comply with rule 1004. Gravel remains throughout the tank battery location and weedy, annual vegetation was observed which includes but not limited to cheatgrass, field bindweed, and kochia.</p> <p>Comply with Rule 1004. Collaborate with the landowner to determine mitigating measures that will allow reclamation work to be conducted in such a manner as to not interfere with agricultural activities or crop production.
