There are areas bare of vegetation and numerous noxious weeds at the location. Previous corrective action was not performed. Corrective action needs to be performed immediately.

Comment: There is now erosion along the access road and at the stream crossing. The culvert at the stream crossing is eroded and is susceptible to being washed out with the next storm event. Areas of erosion must be repaired and BMP's must be maintained until final reclamation is achieved. Corrective action needs to be performed immediately.
