The pump had a new compressor added the week of July 12-16. The noise still continues. The noise is constant. We are noticing the noise more and more. We can hear it in our home even at night when we are trying to watch TV. The dull drone continues on and on. My husband has put in new windows, new thicker insulation and new thicker drywall in an attempt to block the noise. I have moved to the other side of the house to try to find some relief and get some sleep.. Not much relief. The vibration from this pump has caused the prairie dogs to move further way from the compressor. Our quiet way of life is compromised. We have had 4 nights of good sleep. That is when the compressor has gone down for a day. I have been told they are in compliance. They have made some changes. It is still disturbing our life. I have lived here all of my life and this compressor unsettling. I have not heard from the state with any communications. I have been told it is on the website. Try as I might and using a variety pieces of information, I can find nothing. There is a power pole about football field length away. Could an electric pump be put in? I have been told they are much quieter. Or a solar pump? There is a pump near the Cottonwood Rehabilitation Center that makes very little noise. That could be a possibility as well. I have now developed headaches and dizziness since this new pump has been put in. I have have never had health issues until now. Again I am asking to have this pump and the noise fixed. This is my 3rd complaint. I contacted Miles again and he says he has never heard of anything like this before. He says he is sending it to his supervisor. We spend very little time outside because of this noise problem. Again I am asking for relief. Still looking for peace and quiet. Thank you, Barbara Morgan
