Vegetation observed fairly consistent with wetland habitats; vegetation observed predominantly *Carex* and *Juncus* species. *Typha* was observed though in low densities; patches of dense *Phragmites*. Vegetation observed in the adjacent undisturbed upland areas predominantly consists of *Distichlis spicata*, *Chrysothamnus* sp. and various wheatgrass species.
