Operator Comment: SG has completed the interim reclamation on this location. Soils were seeded and straw was tracked on the interim reclamation areas to stabilize the soils. Please see attached photo documentation of seeded and tracked straw in the interim reclamation areas. Erosion control bmp's (straw wattles) were placed in a perpendicular orientation in the outflow channel to prevent and control any potential sediment from leaving the location. These bmp's (straw wattles) are a temporary sediment control measure. As a long term solution, this outflow channel will also be partially lined with rock within a week to prevent and control sediment from leaving the location. SG is also continuing work on the inlet protection.
