General Comment:

This is a final reclamation inspection. Document 2592144 describes plugging the well on 12/1/2010. Corrective actions from May 2021 inspection are not addressed. Change of operator does not exempt the operator from addressing corrective actions according to inspection timelines. The following compliance issues were observed:

- Location is not reclaimed. Per COGCC rules, final reclamation should have been conducted no later than a year of plugging the well (12/1/2011)
 - All equipment needs to be removed and properly abandoned. This includes any inactive flowlines or risers not abandoned that serviced the well.
 - Weeds need to be controlled.
 - Well pad and access road need to be reclaimed to COGCC reclamation standards per 1000 series reclamation rules.
- Corrective action date for all corrective actions listed above: 7/1/2021 This date is back-dated to document original corrective action date for potential enforcement.
