Comment:

Records show well PA 5/2019; Overall reclamation status of the Location is "in process". There are areas on the North and southern ends of the Location where vegetation is predominantly undesirable weedy plant species, though desirable plant germination is evident beneath the weeds; additional time may be required for desirable plants to out-compete weeds, however, weed management strategies should be implemented if it is determined weeds are hindering reclamation.

A pipeline was observed on the east end of the Location cut/exposed and left at the surface; records and historic aerial imagery shows pipeline associated with O&G Location.

Corrective Action: **Comply with 1004 rules; Remove remaining surface equipment/pipeline.**
