Operator Comment: Petrox sprayed all weeds on pad, cut slope and fill slope. Seed outlined in the approved Surface Use Plan of Operations (SUPO) between Petrox and the San Juan National Forest (SJNF) was spread over area needing revegetation. Due to cattle in the area and Petrox not permitted to fence pad or reclamation area, in accordance with the approved SUPO with the SJNF, Petrox will spread more seed and install more aggressive BMPs once cattle are out of the area. Petrox will also reevaluate in Spring, 2022 and add more seed, BMPs and erosion control as needed. Pictures attached.

Operator Comment: Petrox installed waddles on south east corner of fill slope in obvious drainage area. With cattle in the area (photos attached), the waddles were damaged within 12 hours. As stated in corrective action #2, Petrox is not permitted to install fences to keep cattle from the pad or the reclamation area; therefore, Petrox is waiting to install mulch and other Erosion control methods once cattle are out of the area to ensure that BMPs and erosion controls remain in place. Petrox believes this will be in early November, 2021. Additionally, Petrox believes storm water, erosion controls and seeding will need to be reevaluated in Spring 2022.
