Historical soil impacts were discovered following cut and cap operations at the Hauck 7-29 and Hauck 17-29 wellhead locations. The release became State reportable on October 25, 2021, due to the quantity of impacted soil excavated. <p>Following cut and cap operations on October 12, 2021, confirmation soil samples were collected from the base of the wellhead cut and cap excavation areas and submitted for laboratory analysis of benzene, toluene, ethylbenzene, total xylenes (BTEX), naphthalene, and total petroleum hydrocarbons (TPH) - gasoline range organics (GRO: C6-C10) by United States Environmental Protection Agency (USEPA) Method 8260D, TPH - diesel range organics (DRO: C10-C28) and oil range organics (ORO: C28-C40) by USEPA Method 8015D, pH, specific conductance (EC), and SAR by saturated paste method, and boron by hot water soluble soil extract method. Analytical results indicated that constituent concentrations in the soil samples were in compliance with the COGCC Table 915-1 standards, with exception to the SAR result at the Hauck 7-29 wellhead, and the pH and EC results at the Hauck 17-29 wellhead. Excavation and assessment activities are ongoing and will be summarized in a forthcoming quarterly Form 27-Supplemental Site Investigation and Remediation Workplan under Remediation Project No. 20108 (approved Form 27 Document No. 402808670). Based on the analytical results for the samples collected on October 12, 2021, confirmation soil samples from the Hauck 7-29 wellhead will be analyzed for SAR by saturated paste method, and confirmation soil samples from the Hauck 17-29 wellhead will be analyzed for pH and EC by saturated paste method. A topographic Site Location Map showing the geographic setting of the release is provided as Figure 1. Soil sample location and field screening data is provided in Table 1. Field notes and a photographic log are provided as Attachment A. The State Notification email is provided as Attachment B.</p>
