One background sample was collected as part of this investigation approximately 150 feet southeast of the pad surface, which indicated a naturally occurring elevated Arsenic concentration of 3.04 Mg/Kg. Historical background data collected from similar soil types at nearby facilities (Location IDs 334751 and 334656) indicated elevated Arsenic concentrations of 5.1 mg/kg and 6.7 mg/kg adjacent to the PI15 and PJ16 well pads, respectively. The PI15 is located 0.45 miles southeast and the PJ16 is located 1.1 miles southwest of the Site. Historical background data is included as an attachment.
