On Monday 10/18/2021 at approximately 1100, I, Inspector Scott Ramsey, conducted a routine inspection at Caerus PCU 197-34A10, at Location # 413472 in Rio Blanco county Colorado.

While there, I observed normal operations. All meters have been calibrated on location within the past year. This location is within or in close proximity to a CPW Density/High Priority Habitat, black bear, NSO habitat, Wildlife Management Area. Operator (Caerus) has provided documentation of their Best Management Practices for Sediment Tracking Controls.

During this inspection the following compliance issues were observed:

1. Random debris
2. Unused pump house
