INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

A fitting on a produced water dumphine washed out inside the separator dog house resulting in approximately 2 bbls of produced water being released to the ground surface. The impacted soil was removed and hauled to a COGCC approved disposal facility. Thirteen (13) Confirmation soil samples were collected and analyzed in accordance with COGCC Table 915-1.

Thirteen (13) grab confirmation soil samples were collected. Soil samples were analyzed by a certified laboratory. Three initial samples were submitted for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per COGCC Table 915-1, and EC, SAR, pH, and boron.

Based on soil analytical results, additional soil removal was required. Ten (10) additional samples were collected for EC, SAR, pH, and/or boron. Six (6) additional samples were collected for analysis of metals per Table 915-1.

9 samples were collected for metals analysis (sans CR VI) as part of soil boring assessment activities.

All samples collected will be analyzed by a certified laboratory using approved COGCC lab analysis methods.

As of 8/12/21, soil identified to exceed COGCC Table 915-1 was removed and transported offsite for disposal.

REMEDIATION SUMMARY

As of 8/12/21, soil identified to exceed COGCC Table 915-1 was removed and transported offsite for disposal. Residual soil concentrations in metals exceed COGCC Table 915-1 protection of groundwater soil screening levels (GSLs), only. A site investigation was completed 9/8/21 to determine the applicability of GSLs at the site. Direct push refusal was encountered at 7 feet bgs adjacent to the release location. Solid stem augers were utilized to complete a temporary, 1" well at 20 feet bgs. Groundwater was not observed during the assessment or subsequent gauging.

Residual metals in soil at the site do not exceed COGCC Table 915-1 residential soil screening levels and appear feasibly delineated and naturally occurring. Based on the confining layers observed during the soil boring assessment and lack of groundwater at the site, COGCC Table 915-1 protection of groundwater soil screening levels do not appear applicable.
