Comments:

We ripped the location, spread gypsum, and re-planted this spring. The grass coverage is thick. It was seeded with a native grass mixture. The shorter varieties took in this location better than the taller spindly variety of which the surrounding area has a lot growing. Other locations which were seeded at the same time had much more of the spindly variety growing. We're guessing nature chose the shorter varieties for this site. With time, the pasture may morph, but if grazed, I'm certain the cattle would love this lush new growth.
