Basis for Review: Corrective action dates are not attainable

Operator Comment: This corrective action was for 'unused tubing and rods at pumping units.' Confluence respectfully requests the COGCC allow us to keep surplus rods and tubing on location in an orderly fashion and on pallets as the subject tubing and rods are today. Confluence regularly has to repair rod or tubing failures on these three Flaherty rod-pumped wells. When we order replacement rods and tubing, we often have a few surplus joints left. Consequently, we store them on a pallet to be used in the next rod or tubing failure workover. Therefore, this isn't unused equipment, but equipment that goes downhole in a well on a regular basis. Can we continue to proceed with this method?

COGCC Supervisor: Rods and tubing will be allowed to remain stored at wellhead in an orderly fashion.
