	<p>The well location and access road appear to meet final reclamation regulations and standards, and appear reflective of reference areas. Unable to find evidence of oil and gas activities and/or disturbances.</p> <p>The tank battery location does not comply with Rule 1004. Gravel remains throughout the location and has not been re-contoured or re-graded; weedy, annual vegetation was observed which includes but not limited to puncture vine, field bindweed, and kochia. A List B CO Noxious weed, Musk thistle, was observed and flowering at the location.</p>	
Corrective Action:	<p>Comply with Rule 1004. Collaborate with the landowner to determine mitigating measures that will allow reclamation work to be conducted in such a manner as to not interfere with agricultural activities or crop production.
