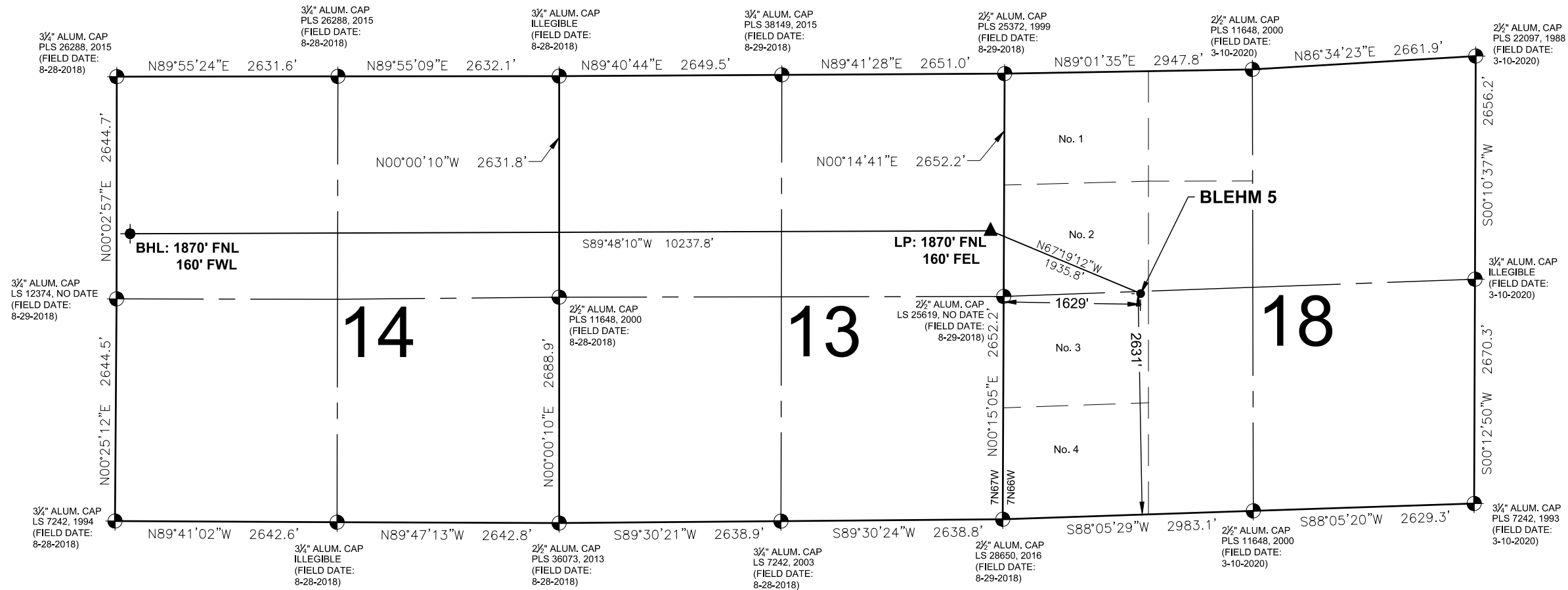


BLEHM 5

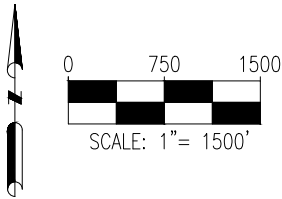
