The site was reseeded on 3/9/2021 and weeds were sprayed in March. The site was inspected by an independent contractor on 6/22/2021 who has recommended that the operator request closure for this site. The operator has submitted Form 4 document #402822662 requesting approval from the reclamation department. The attached report, including photographs, states that the site has reached 70% vegetation compared to background and subsequent communication from the contractor stated that the site had reached 80%. Susan Sherman conducted an inspection on document #688311401 agreeing that the site has met 80%. She has approved the Form 4 with consent of Chris Binchus and the Form 4 is pending final approval by Chris Binchus.
