Comment: Inspection #696203197 provided notice to Caerus that control measures to stabilize the location, and to mitigate tracking and offsite sediment transport were showing signs of degradation. Inspection directed Caerus to monitor and manage site for stormwater, and to ensure BMPs are maintained.

It was observed in this inspection that control measures to stabilize the production areas of the Location, and to mitigate tracking and offsite sediment transport have not been maintained in proper functioning condition, and are in disrepair.

The date of inspection is being provided as the CA date, as Caerus was provided prior notice of the imminent failure of their control measures.
