The planned construction depth was 910-ft, static water level recorded at 200 ft. Monitoring Hole (DWR Receipt 0022014, Permit 22014-MH), now abandoned, is approx. 5740-ft to the E. The construction depth is not recorded, this well was bailed dry. The Monitoring Well (DWR Receipt # 0053644, Permit 5344-MH) is approx. 6260-ft E. This well was constructed to 22-ft, no static water level recorded. Residential Well (DWR Receipt # 0097464, Permit 101982-A) is approx. 7250-ft E. This well was constructed to 46-ft, and static water level recorded at 5 ft.

Groundwater less than 20 ft is not expected at the disturbance location.

This location is not within a HPH area.

Grab confirmation soil samples were collected from beneath the above ground oil tanks, produced water tank, separators, and wellhead. Additional soil samples were field-screened for possible impacts. Soil samples were analyzed by a certified laboratory for TPH ([C6-C36]), organic compounds in soil per COGCC Table 915-1, and EC, SAR, pH, and boron. All samples collected were analyzed by a certified laboratory using approved COGCC laboratory analysis methods.
