Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until the location meets Rule 1003 standards, including stormwater and weed management.

Since it is not ideal to perform seeding operations during the hot, summer months, revegetation activities shall be complete no later than 11/15/21 or as soon as environmental conditions will permit.
