Basis for Review: Corrective action dates are not attainable

Operator Comment: The ECD pilot light was lit during the time of inspection. Lease operator provided information to the inspector during the inspection on Tuesday, November 10, 2020 confirming that the pilot light was lit. Inspector disregarded information provided by lease operator. Lease operator shut in ECD and adjusted pilot light position so that it could be more easily viewed. Lease operator again provided information to the inspector that metal inside the ECD was warm to the touch, indicating the ECD pilot had been lit prior to being shut in. Inspector once again disregarded information provided at the time of inspection. Produced gas was being sold at the time the inspection occurred. No bypass or upset conditions or malfunctions occurred at the time of inspection, eliminating the possibility that venting or flaring activities were occurring.

The ECD on location is specific to the control of storage tank emissions: working losses, breathing losses, and flashing losses. Control of these specific storage vessel emissions does not warrant approval from the COGCC for venting or flaring. The storage vessels at the HORST-SCHUTT tank battery are not required to be controlled per AQCC Regulation No. 7. KPK voluntarily controls storage vessel emissions at this location through the operation of the ECD. An unlit pilot light is not a violation of any rule or regulation at a voluntarily controlled location.

COGCC Decision: Approved pending re-inspection

COGCC Representative: At time of inspection Pilot was not lit. I physically opened cap to make sure. My conversation with pumper was about ECD having a mechanical issue due to the fact that is was the second time pilot was out in 6 days. We also discussed Marvin E Unit #1 complaint about gate being open. Not at any time during my time on location did pumper discuss adjusting pilot light or metal being warm this is a false statement. Pumper spoke with environmental state personal.
