The gate and fencing that was a previous complaint has been completed. Germination of desirable plant species was observed along the eastern location but most of the well location consists of Kochia. Canada thistle rosettes were observed sparratically in areas of the location. Surface owner indicated that Noble had plans to re-seed this Fall.

The eastern access road and tank battery are mostly weeds with no desirable establishment observed, which is on a different surface owner from the well location. Refer to the attached inspection photos.

Comply with Rule 1004. Final reclamation activities shall be completed as soon as possible.
