Any Corrective Actions from previous Inspections that have not been addressed are still applicable.

On Monday 11/22/2021 at approximately 1400, I, Inspector Scott Ramsey, conducted a routine inspection at 31 Operating WRD Fed 33-44, at Location # 316153 in Rio Blanco county Colorado.

While there, I observed no production operations and labeling on location/meter house have a different operator (KT Resources). Emergency phone # has also been changed, I contacted the emergency contact without fail (KT Resources). Wells are shut in. All meters have been not calibrated on location within the past year. This location is within or in close proximity to a CPW Density/High Priority Habitat, black bear, NSO habitat, Wildlife Management Area. There is no evidence of tracking pad at time of inspection.

During this inspection the following compliance issues were observed:

1. Access road/location in areas shows signs of lack of stabilization/compaction.
2. No evidence of tracking control BMP's.
3. Erosion channels on fill slope of location with sediment migration from pad.
4. Locations weeds have turned into debris throughout location.
5. Lack of tank battery signage.
6. Location signs are incorrect.
7. One chemical tank is not labeled.
8. No visible Braden head access.

A follow up on this site inspection will be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
