#### COMMENTS:

The third party gatherer/purchaser has permanently abandoned the sales line system. Production gas is currently used to run production equipment. Given the low gas production, it is uneconomic to install equipment to capture the gas and generate electricity, install a gas lift system, install new infrastructure to sell gas, etc. KPK is still working with several midstream operators to determine if the pipeline can be acquired or connected to another third party gatherer. KPK is also trying to find other beneficial uses for the gas.
