COMMENTS:

The existing gathering sales line is being abandoned by Anadarko Midstream. Production gas is currently used to run production equipment, but sometimes this gas is not enough for such purposes, which forces KPK to occasionally supply the production equipment with propane. Given the low gas production, it is uneconomic to install equipment to capture the gas and generate electricity, install a gas lift system, install new infrastructure to sell gas, etc. KPK is still working with several midstream operators to determine if the pipeline can be acquired or connected to another third party gatherer. KPK is also trying to find other beneficial uses for the gas. Well does not produce enough gas to justify the cost of the equipment to generate electricity, use gas lift, have an EOR, or to compress the gas and store it. Well gas is used to run separator and ECDs. KPK plans to flare in perpetuity or until new infrastructure is put in place. KPK is currently exploring alternatives to use existing infrastructure and avoid flaring.

The estimated volume of gas to be flared is 300 mcf/m. The BTU content is 1,338. There is no H2S in the gas stream. This facility has been and will continue to be operated in full compliance pursuant to the applicable requirements of Colorado's Air Quality Control Commission's Regulation No. 3 and Regulation No. 7, including Sections XII & XVII.
