Operator Comment: Hand dug a series of 24 small test holes on the top soiled portion of the CC 697-16-28 pad. Based on those results, the pad has an average depth of topsoil of 4 inches on the northeast side of the location. Four inches spread over that area works out to approximately 550 cubic yards of topsoil on location.

Corrective action required Operator to identify how much topsoil is being stored for final reclamation, and its Location. Operator certifies and states within this resolution that there is 550 cubic yards of topsoil on the northeast side of the Location; Operator has also provided additional figures showing the Location of the topsoil, as well as a "Construction Lay Drawing" (dated 2/17/2011) for the southern section of the Location.

It is noted that Operator failed to follow the corrective action and submit the required documentation attached to a Form 4.

It is also noted, based on the calculations provided, that topsoil salvage does not appear to have been conducted in accordance with COGCC 1002 Rules, and the amount of topsoil currently stored (550 cubic yards) appears insufficient for future reclamation of the Location.

Additional review of the issue is being conducted internally.
