The root cause of the contamination is unable to be determined. Work to replace the flowline was scheduled because the line was plugged with paraffin, and after the plug was unable to be broken the work to replace the flowline began. The fiberglass flowline was destroyed by the excavation equipment in the process of removing it, so there is no way to determine if there was an active leak on the flowline. Based on the weathered look of the contaminated soil and no observed "fresh" contamination, KPK believes this is a historical spill.
