Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of pre-disturbance or reference area levels. Use a seed mixture requested by the surface owner, or a mixture prescribed by the local soil conservation district. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage interim areas until Final Reclamation has passed. A corrective action of 3/1/2016 is being provided as this is when Laramie took ownership of the Location.

Operator Comment: Commission Docket No. 210800138 filed 8/24/21 for "2021 Cascade Creek Oil and Gas Development Plan" describes the re-engineered plans to expand the CC 603-23-32 to accommodate an additional 24 wells by expanding the location and additional 3.9 acres of new well pad disturbance as well as .82 acres of new disturbance for an existing pipeline re-alignment. Once the wells are drilled and completed, the pad will be interim reclaimed back to 3.2 acres of working area.
