In accordance with COGCC Rule 911 and Rule 915 soil samples, and groundwater samples if present, will be collected during closure of each qualifying equipment type and field screened. If suspected impacts are identified, they will be submitted for laboratory analysis of Table 915-1 constituents. If no suspected impacts are identified, field-screening results may be reported in lieu of laboratory analysis. If a release is confirmed through laboratory analysis, additional excavation effort may be conducted to delineate horizontal and vertical extents. Discrete soil samples will be collected and analyzed for Table 915-1 constituents pursuant to Rule 915.e. Overburden stockpiles, if present, will be sampled prior to use as backfill with a frequency of 1 composite sample per 500 cubic yards of material and submitted for analysis of VOCs.

Seven background samples were collected as part of this site investigation including BKG01@6", BK02@5', BKG03@1', BKG04, BKG05, BKG06, and BKG07. These background samples collected from nearby, non-impacted native soils show that elevated metal levels are naturally occurring in the native soils in the area. pH was also found to range widely onsite, with background pH values ranging from 5.99 to 8.47.

OPERATOR COMMENT

This form has been prepared to document successful removal of the production equipment associated with this location, as well as successful closure of the pit located onsite (via sample Pit-01@4.5') . Residential screening levels were utilized at this location because the static water level is deeper than the removed equipment, and there was no evidence of groundwater present during any site visit. Analytical data shows two samples (SEP01@6" and PWVB01@4') exceeded Table 915-1 residential screening levels for arsenic. However, these areas were dugout to remove elevated arsenic soils, and confirmation samples were collected (SEP02@3' and PWVB02@6'). Seven background samples were collected from nearby, non-impacted native soils which show that elevated metal levels are naturally occurring in the native soils in the area. Background samples collected during the investigation also indicate pH ranging from 5.99 to 8.47, demonstrating pH levels vary widely across the site. Please find attached a Topographic Map, Site Diagram, Lab Results Summary Table, a copy of the laboratory results, Tank Battery and Flowline Closure Checklists, and a photolog.
