On 11/30/2021 Catherine Roy conducted a reclamation and stormwater inspection. During this inspection the following compliance issues were observed:

-Stormwater BMPs need maintenance/repair throughout the project area. Erosion (ie: seeding/mulching, erosion control blankets, etc.) and stormwater controls (BMPs) need to be installed on the well pad cut-slope as wattles are not adequate BMPs here. Controls need to be selected, sized, installed, and maintained according to good engineering practices such as those described by CDOT in their erosion control manuals. Comment Revegetation is progressing within portions of the interim reclamation areas. However, bare soils on the well pad cut-slope remain unstabilized. Erosion controls (ie: erosion control blanket, hydromulch, etc.) need to be installed and maintained in place until stabilized with desirable perennial vegetation.

Comment: Wattles on the well pad cut-slope are not longer functioning and are not an adequate BMP in this area. Diversion channels are full of sediment and need maintenance. The southeastern diversion from adjacent well pad is washed out, demonstrating that cobble (course rock is recommended) is not adequately sized for this area.

Corrective Action: -Stormwater BMPs need maintenance/repair throughout the project area. Erosion (ie: seeding/mulching, erosion control blankets, etc.) and stormwater controls (BMPs) need to be installed on the well pad cut-slope as wattles are not adequate BMPs here. Controls need to be selected, sized, installed, and maintained according to good engineering practices such as those described by CDOT in their erosion control manuals.
