COMMENTS:

TEP Rocky Mountain LLC (TEP) is reporting that the bradenhead on the Dotson RMV 17-27 well has been connected to an enclosed combustor as part of a Pressure Management Plan. On July 1, 2021, the Dotson RMV 17-27 well had a bradenhead pressure of 113 psi. This well has a surface casing depth (TVD) of 296' giving the well a calculated threshold pressure of 89 psi. TEP performed a blowdown test and submitted the test results, via a Form 17, on July 7, 2021. A copy of the Form 17 is included in the "Related Forms" section. TEP monitored the bradenhead pressure after performing the test and determined that the bradenhead pressure would continue to build and sustain pressures above the threshold pressure. Due to the low calculated threshold pressure and the sales line pressures averaging 145 psi, connecting the bradenhead to an enclosed combustor was our only viable option to manage the bradenhead pressure and maintain a pressure below the COGCC threshold. On November 29, 2021, TEP connected the bradenhead to an enclosed combustor after experiencing delays due to parts and crew availability. A diagram depicting the bradenhead connection to the enclosed combustor is attached.
