General Comment:

COGCC Inspection Report Summary
On Thursday 12/2/2021 at approximately 1200, I, Inspector Scott Ramsey, conducted a routine inspection at TEP RWF 33-22, at Location # 335367 in Garfield county Colorado.
While there, I observed normal production operations. All meters have been calibrated on location within the past year. This location is within or in close proximity to a CPW Density/High Priority Habitat, black bear, NSO habitat, Wildlife Management Area. Operator (TERRA) has provided there Piceance Basin Storm water Manual of BMP's (SC-4) for a tracking pad, there is no evidence of tracking pad at time of inspection.
During this inspection the following compliance issues were observed:
1. Load lines missing bull plugs/caps.
2. Horizontal separators includes 4 glycol storage tanks, storage vessels contains no labeling to specify capacity or chemical hazard information.
3. Location/access road shows signs of lack of stabilization/compaction and erosion with sediment migration.

Refer to photograph of observed compliance issue.
A follow up on this site inspection will be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
