Final Reclamation has not been conducted at this location. COGCC inspection 689901702 on 1/28/2020 documented compliance issues with Final Reclamation. COGCC inspection 673803891 on 11/23/2016 documented that a variance request for final reclamation was in process. This variance request has not been approved and no final reclamation activities have been conducted to date.

The LOBO #13-4 well was plugged and abandoned on 7/18/2013.

The location is not in compliance with the Final Reclamation requirements.

Final Reclamation was not completed within 12 months of abandonment.

This inspection is being entered for notification and documentation only and is not intended to provide the Operator the opportunity to resolve the alleged violations without the imposition of a penalty, pursuant to Rule 523.b.(1).
