Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

Caerus plans to collect soil samples to delineate encountered TPH impacts associated with the dehydration unit tank on 11/04/2021. Laboratory results of initial investigation and characterization samples indicated compliance with COGCC Table 915-1 Soil Suitability for Reclamation (SSR) and metals standards except for pH, arsenic, and chromium (VI). Background samples collected at the location indicate that the pH and arsenic exceedances are within naturally occurring levels. The chromium (VI) exceedances are labeled with a "J" qualifier; stating that the identification of the analyte was made, however, the concentration is only an estimate due to the minimal amount of the analyte being exhibited in the sample material. Therefore, Caerus is requesting the consideration of the "J" qualifier, acceptance of the background data based on COGCC Table 915-1 Footnote 1, and COGCC approval of a reduced analyte suite of TPH for future soil samples collected in association with these impacts.
