### INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

This form has been prepared to summarize assessment activities conducted during the partial closure of the Drilling 27C, 27N-32HZ O facility. Two above ground storage tanks (ASTs) and three emission control devices (ECDs) were permanently removed. Assessment activities began on June 6, 2021. Soil assessment activities were conducted in accordance with COGCC Rule 911.a. A photo log is included as an attachment.

On June 6, 2021, soil samples were collected from the two ASTs, three ECDs, and ancillary piping (see Figure 1). The soil samples were field screened for total volatile organic compounds using a photoionization detector (PID). Based on PID readings, select soil samples were collected from the two ASTs and submitted for laboratory analysis in accordance with COGCC Rule 911.a. Analytical results indicated soil was in full compliance with Table 915-1 standards or within the analytical variability of the background sample. Therefore, further excavation was not warranted. The soil sample results and PID readings are summarized in Tables 1 and 2, respectively. The laboratory report is attached.
