**General Comment:**

Inspection to verify access road relocation per the landowner's request and Form 4 #402885042.

Landowner requested that the access road be a straight line to the location vs. following the banks of Coal Creek (see attached map). The pad was under construction with a ditch installed around the pad prior to beginning of construction. The access road had not been constructed at time of this inspection. See attached photos that include GPS coordinates and elevations. The Crystal pad is in a pasture with cattle and operator stated that a fence (livestock at other locations) would be constructed. Topsoil was a loam.

Floodplain (FEMA) areas in Coal Creek are mapped near the Crystal pad entrance and 253' from SE most well on the Crystal pad (039-06752). Wetlands are mapped in Coal Creek 875' south of southern row of wells on the Crystal pad. Per Rule 1202c the Crystal pad is in High Priority Habitat for Aquatic Native Species Conservation Waters. Per Rule 1202d the Crystal pad is in Density Habitats for the Mule Deer Severe Winter Range. The Operator stated that they contacted the regulatory agency about the floodplain and the Mule Deer habitat.
