Operator Comment: reclamation grading/contouring/reseeding at the tank battery site for the subject location. For the portion that was removing the abandoned riser, this action is now completed. Pictures are attached that detail the removed riser and show the reseeded ground on that end of the tank battery site.

Confluence intends to perform the 'grading/contouring/reseeding of the remainder of the tank battery site' portion of the CA at the end of September 2021.

UPDATE - Confluence hired Advanced Contracting Group to perform final reclamation on the subject tank battery site on 11/22/2021. The tank battery site did not require any grading/contouring, but a high speed disc prepped the topsoil and a drill seeder was used to innerseed existing stands of grass. This work was originally planned for September 2021, but was postponed for cooler temperatures to prevent seed germination prior to winter. A picture is attached that shows the tank battery site post-final reclamation.
