Proposed Procedure:

1. MIRU pulling unit. Pull 2 3/8" tubing.
2. RU wireline company.
3. TIH with CIBP. Set BP at 6503'. Top with 2 sxs 15.8#/gal CI G cement. (Top of Nio perms @ 6553')
4. TIH with CIBP. Set BP at 2500'. Top with 2 sxs 15.8#/gal CI G cement.
5. Wait a sufficient time to confirm static conditions. If at any time after placing this plug there is evidence of pressure or fluid migration, contact engineering before continuing operations.
6. Pick up tubing to 1645'. RU cementing company. Mix and pump 125 sxs 15.8#/gal CI G cement down tubing. Cement should circulate to surface. (Pierre Coverage from 1645' to surface)
7. Well casing cut and capped per COGCC guidelines at a depth as not to interfere with soil cultivation.
