Operator Comment: SG believes the correct identifying inscription as required by Rule 434.a.(5) exists on the steel plate welded to the top of the casing of the plugged and abandoned well. Multiple SG employees and contractors viewed the steel plate on separate dates. Please see the attached photo documentation of the plate and the Daily Report from the PA crew that states the required information was welded on the plate.

At the time SG received the Field Inspection Report (12/06/2021) related to this issue, earth moving related to final reclamation had been completed, and the steel plate is now buried under approximately 8-10' of soil. If COGCC is not satisfied with the attached documentation, SG requests that we be allowed to conduct work to confirm compliance with Rule 434.a.(5) in the summer months of 2022. Currently, the location is seeded, mulched, and snow and frozen soil exist on this location.
