The separator and associated glycol bath are considered a process vessel. They are not a Tanks, as defined by the rules, as they do not contain "produced fluids or E&P Waste," nor are they a Containers as they are not portable devices and do not contain "hazardous material." Rule 605.h. applies to specifically to Tanks and Containers; as these process vessels are neither, they are not subject to Rule 605.h. and this corrective action is not applicable:
TANK shall mean a stationary vessel constructed of non-earthen materials (e.g concrete, steel, plastic) that

provides structural support and is designed and operated to store produced fluids or E&P waste. Examples include, but are not limited to, condensate tanks, crude oil tanks, produced water tanks, and gun barrels. Exclusions include Containers and process vessels such as separators, heater treaters, free water knockouts, and slug catchers. CONTAINER shall mean any portable device in which a hazardous material is stored, transported, treated, disposed of, or otherwise handled. Examples include, but are not limited to, drums, barrels, totes, carboys, and bottles.
