INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

This form has been prepared to summarize assessment activities conducted during the plugging and abandonment of the Doris Ackerson B 1 wellhead, and the removal of a portion of the associated flowline. In 2018 the production facility, and a portion of the flowline, associated with the Doris Ackerson B 1 wellhead, were removed in preparation for the Leinweber Fed 32N 5C 5NHZ O SA production facility construction. Assessment activities began on February 22, 2021. Soil assessment activities were conducted in accordance with COGCC Rule 911.a.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

☒ Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

Between February 22 and May 7, 2021, soil samples were collected from the wellhead excavation and flowline potholes. The samples were field screened for total volatile organic compounds using a photoionization detector (PID). Based on low PID readings at the flowline, soil samples were not submitted for laboratory analysis. Based on PID readings from the base and sidewalls of the wellhead excavation, two samples were submitted for analysis. Analytical results indicated soil was in full compliance with Table 915-1 standards at the extent of excavation, except for selenium. Background soil samples indicated boron and selenium are naturally occurring at these levels in the native soil. Therefore, further excavation was not warranted. The wellhead excavation and flowline are depicted on Figure 1 and Figure 2, respectively. The soil sample results and PID readings are summarized in Table 1 and Table 2, respectively.

Proposed Groundwater Sampling

On February 22, 2021, one groundwater sample (GW01) was collected from the wellhead excavation for Table 915-1 analyses. Based on the laboratory analytical results groundwater concentrations for sample GW01 exceeded COGCC Table 915-1 allowable levels for chloride and sulfate. The excavation groundwater sample location is depicted on Figure 1. The groundwater sample analytical results are summarized in Table 3.

Approximately 150 cubic yards of impacted soil were removed from the site and transported to Front Range Landfill in Erie, Colorado, for disposal. Approximately 205 barrels of impacted groundwater were removed from the site and transported to Aggregate Recycle Facility in Weld County, Colorado, for recycling. Disposal records are kept on file and available upon request.
