Comments:

The former HSR-ZELDA 13-25 well (API: 05-123-20381) was P&A'd on May 14, 2001 according to Form 6 Document Number 01099105. On September 22, 2021, OXY conducted a final reclamation inspection for the former HSR-ZELDA 13-25 well pad (Location ID: 409554). The former well pad has successfully been returned to agricultural use. The inspection determined that final reclamation has been achieved in compliance with COGCC Rule 1004, which applies to reclamation of agricultural lands. The associated tank battery is located 0.52 miles southeast of the well pad. Well was dry and abandoned, location was not plumbed to tank battery. There is not a flowline or facility associated with HSR-ZELDA 13-25. The tank battery in photo (Location ID 331602) was built to service the HSR-ZELDA 13-25 if well was not dry and abandoned. Oxy used COGCC as drilled coordinates to locate the well and photographed using drone photography. A general site location map is included as Figure 1; and the Site Map displaying the location of the reclaimed site on aerial drone imagery captured on September 22, 2021 is included as Figure 2. Photographs of the P&A location were taken facing each cardinal direction from the P&A wellhead location. The photographic log is included as Figure 3.

Based on the successful reclamation of this site, a Form 4 Sundry Notice requesting final reclamation status has been prepared for submittal to the COGCC. This letter will be included as an attachment to the electronic Form 4 submittal.
