Description of Corrosion Protection:

Corrosion protection for this line utilizes a rectifier located at the HUB facility. The Produced water transfer line also is fully coated internally and externally to further prevent corrosion potential. Rectifier system is checked every 6 months by third party contractor to ensure that it is functioning as intended.

Description of Integrity Management Program:

Produced Water Transfer Line is installed in accordance with 1102.b applicable technical standards. Operation of the pipeline is monitored in a control room by operators who are specifically trained on operating the transfer line and can shut in if abnormal conditions are suspected. Pressure testing per rule 1104.f of the transfer line is conducted annually. In the event repairs are necessary on the transfer line, all applicable rules will be followed to safely repair the transfer line.

Construction method used for all public by-ways, road crossings, sensitive wildlife habitats, sensitive areas and natural and manmade watercourses (i.e., bored and cased or bored only)

The transfer line was installed using best management practices, Pipeline was installed in an open trench following all applicable rules. When crossing a road and watercourses, bore and casing was used where required by local municipality to minimize all impact to surrounding areas. In areas that a bore and casing was not required, a bore was used.
