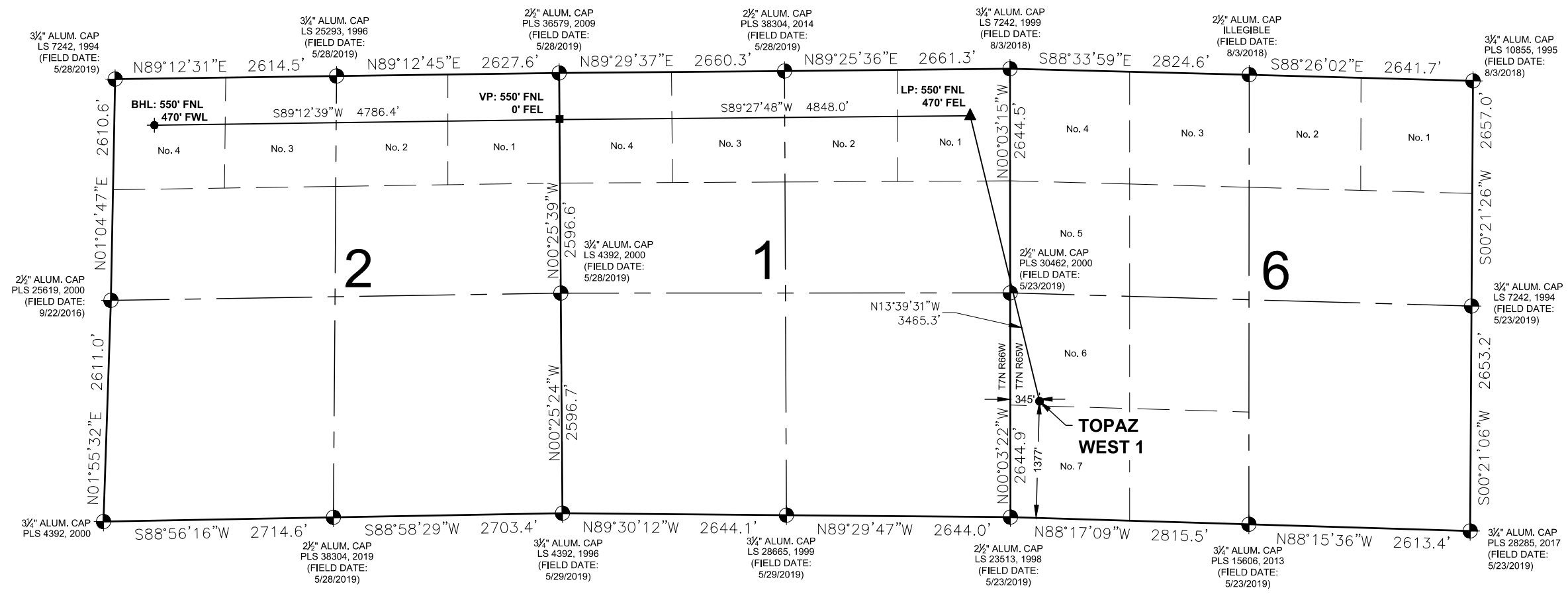


TOPAZ WEST 1

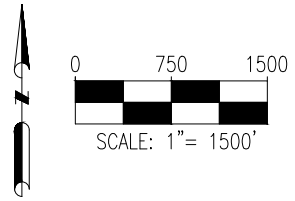
