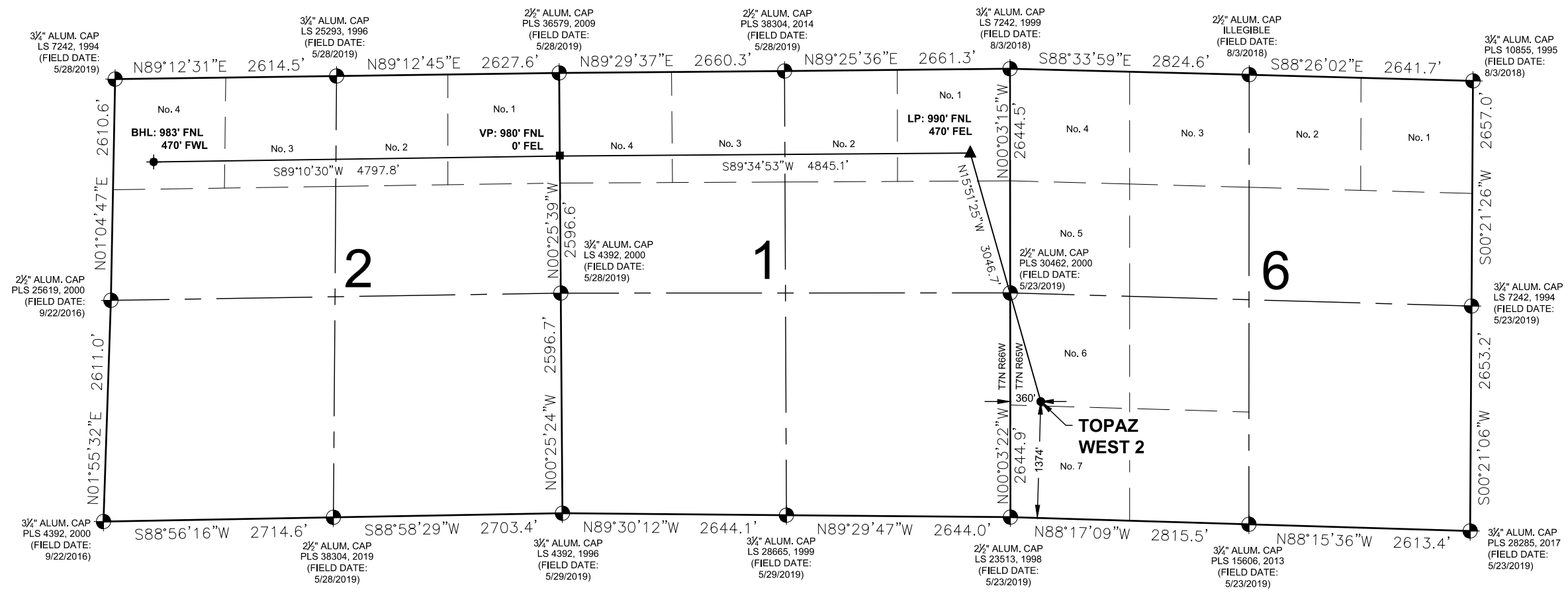


TOPAZ WEST 2

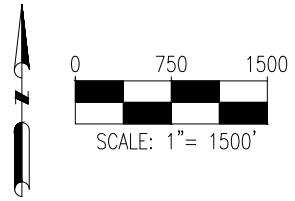
