Citation Oil & Gas Corp. requests approval to retain this well in a temporarily abandoned status. There is a CIBP set at 5153' with 2 sxs cement on top isolating the Morrow perms at 5203'-5305'. There are valves and plugs in the tubing and casing closing off the well to the atmosphere. The well was originally abandoned due to low production, however we hope to complete an evaluation this year on the well for potential conversion into a water disposal well for the Bill lease pending a rise in oil prices.
