**General Comment:****COGCC Inspection Report Summary**

On Friday 12/3/2021 at approximately 1200, I, Inspector Scott Ramsey, conducted a routine inspection at Caerus C7, at Location # 334560 in Garfield county Colorado.

While there, I observed well was shut in. All meters have been calibrated on location within the past year. This location is within or in close proximity to a CPW Density/High Priority Habitat, black bear, NSO habitat, Wildlife Management Area. Operator (Caerus) has provided documentation of their Best Management Practices for Sediment Tracking Controls.

During this inspection the following compliance issues were observed:

1. Vertical unit and horizontal separators includes 2 glycol storage tank, storage vessel contains no labeling to specify capacity or chemical hazard information.

2. Load lines missing bull plugs/caps.

A follow up on this site inspection will be conducted to ensure the compliance issues have been corrected to comply with COGCC rules. This is a summary of inspection report.
