1	Drilling/Completion Operations	Alternative Logging Program: One of the first wells drilled on the pad will be logged with open-hole resistivity log and gamma-ray log from the kick-off point into the surface casing. All wells on the pad will have a cement bond log with gamma-ray run on production casing (or on intermediate casing if production liner is run) into the surface casing. The horizontal portion of every well will be logged with a measured-while-drilling gamma-ray log. The Form 5, Completion Report, for each well on the pad will list all logs run and have those logs attached. The Form 5 for a well without open-hole logs shall state "Alternative Logging Program - No open-hole logs were run" and shall clearly identify the type of log and the well (by API#) in which open-hole logs were run.

This sundry is being submitted to amend the Seltzer LD 09-371HN well which spud 4/10/2020 and had surface casing set. A preliminary Form 5, document #402430057, was submitted 7/2/2020. Surface casing setting depth on this sundry reflects the drilling rig's KB elevation and will differ from the preliminary Form 5 submitted. This well is changing TPZ, BPZ, BHL, and proposed total depth as well as casing and cement plan. Updated Offset Well Evaluation, Well Location Plat, Deviated Drilling Plan, and Directional Data Template are attached. This well has a bottom hole location beyond the unit boundary setback. The bottom of the completed interval will be within the unit boundary setback at 470 FSL and 2600 FWL of Section 9. The wellbore beyond the unit boundary setback will be physically isolated and will not be completed.
