Comment: The trailer and cable have been removed. There was reclamation performed on only a portion of the location. The rest of the location was not reclaimed and consists of undesirable weeds. The entire disturbance area of the location must be reclaimed. Soils must be decompacted by cross ripping to at least 18 inches. The seeded soils were lightly straw mulched and the mulch was not crimped into the soil. Additional stabilization of soils is needed. Straw mulch should be certified weed free. Previous corrective action was not completed.
